How we can help you

What happens next?

You are likely to be wondering what happens now that the case has been reported by the police to the Procurator Fiscal (responsible for investigating and prosecuting crime in the area). You may be worried about:-

- your safety
- dealing with unfamiliar procedures and language
- speaking about very personal or intimate issues
- how people will react to you and what has happened
- coping with the physical and emotional aftermath of the crime

Procurator Fiscal staff will treat you professionally and sensitively. They are not here to judge you or make assumptions about you. Their job is to find out all they can about what happened and decide whether the case should be prosecuted.

About Victim Information and Advice (VIA)

VIA is part of the Crown Office and Procurator Fiscal Service. VIA staff are not investigators or prosecutors. We are here to:-

- provide you with information about how the criminal justice system works and what to expect
- keep you up-to-date on progress and key developments in your case
- help you get in touch with organisations that can offer you practical and emotional support (see list at end of leaflet)
- discuss what support may be available to help you give evidence or attend court if the case goes to trial

If you do not want VIA's help, just let us know. If you then change your mind, please contact us.

We hope this leaflet will answer some of the questions you may have. Please ask us if there is anything you are unsure about or anything else you would like to know.

What happens when someone is accused of a sexual crime?

The police will investigate the allegation and only where the police think there is sufficient evidence to support the allegation, will a report be sent to the Procurator Fiscal.

The Procurator Fiscal will then consider the police report at this preliminary stage and decide if there is sufficient evidence and if it is in the public interest to begin criminal proceedings against the accused. The Procurator Fiscal may also instruct the police to carry out further enquiries before deciding whether to begin criminal proceedings against the accused.

If the Procurator Fiscal decides to begin criminal proceedings, the accused will appear in court. The judge will decide whether the accused should be kept in custody (prison) or released on bail while the case is prepared. VIA will tell you if the accused has been granted bail (and, if so, what conditions apply) and what will happen next.

What does "public interest" mean?

Where there is sufficient evidence in a case, the Procurator Fiscal will require to consider a number of additional factors when deciding whether criminal proceedings should take place. This is often referred to as assessing the 'wider public interest'. It means that the Procurator Fiscal will look at the case from the point of

view of the wider community, as well as that of the victim and the accused.

The Procurator Fiscal will look at a number of factors – for example, the nature and seriousness of the crime, its impact on the victim and other witnesses, the wider circumstances of what happened and who was involved. If you would like further information about a decision taken in your case, you can ask the Procurator Fiscal for this.

What if you decide not to prosecute?

You, as a victim of crime in Scotland, have the right to a review of a decision by us not to prosecute, made on or after 1 July 2015. You should if possible apply for a review within one month of the date you are informed of our decision not to prosecute. Generally you would be told of the review decision within 20 working days.

Will there be a trial?

Where a decision has been made by the Procurator Fiscal to prosecute and the accused pleads not guilty, a date will be set for a trial. VIA can explain to you how the court system works and will keep you informed of progress in the case. For example, a hearing (called an intermediate diet) will be held to check that the prosecution and defence are ready for trial and that the accused is still pleading not guilty. If the accused pleads guilty there will be no need for a trial. If a trial does take place the case will be decided by a judge and there is no jury involved.

What key developments will I be told about?

Where a decision is taken to prosecute, we will tell you about the following:-

- dates of court hearings
- whether the accused pleads guilty to the charge(s)
- outcomes of court hearings
- decisions about bail (and any changes to bail conditions)
- the trial verdict (you are entitled to be present if you wish)
- sentence (may be passed on the same day as the verdict or later)
- any appeal against sentence or conviction

You will also be informed if the prosecutor is considering accepting a guilty plea to a significantly reduced charge from the one with which the accused was originally charged or if there is any decision to discontinue proceedings prior to the case calling for trial. If either of these decisions are made, you can ask the Procurator Fiscal for a meeting to discuss the reasons for the decision.

I am worried about attending court

VIA staff will explain the court process to you and will ask you if you would like to visit a court before the trial to get a better idea of what to expect.

If you are worried about seeing the accused or their family or friends at court, we may be able to make arrangements to help with this. If you have any concerns about your safety, let the police or court staff, and VIA, know.

I am worried about giving evidence

You are entitled to special measures to help you give your evidence. These include:

- a screen in the courtroom. This means that you will not be able to see the accused person but you will still be able to see the judge, the prosecutor, lawyers and other court staff
- using a live television link. The link may be from another room in the court or from another building
- having a supporter in court with you. This means that you could have someone sitting with you, for example someone from a support organisation

I am worried about the types of questions I may be asked while giving evidence

There are rules about this and the judge must make sure these are followed.

The defence (or the prosecutor) must ask the judge in advance if they want to ask questions about your character or sexual history. VIA will tell you if this happens and what the judge decides. If particular questions are allowed, the Procurator Fiscal dealing with your case may need to speak to you again and may take another statement from you.

Will my personal details be disclosed in court?

Your address should not be read out in court unless it is where the crime took place. But it may come out at the trial if the crime was seen from that address or an item was recovered from it but even if that is the case, care will be taken to ensure that, where possible, your privacy will be respected. You should not be identified in the newspapers, on radio or television. If you are worried about this, you should contact the Procurator Fiscal or VIA to discuss your concerns.
