# 4. Finance Update 2021-22

MA presented Paper RC 24 (2022)

General highlights included:

- The COPFS Annual Accounts for 2021-2022 were signed on 14 September 2022 and are scheduled to laid before the Scottish Parliament in due course.
- The accounts show a resource underspend of £1.7m and an overspend of £18m after AME adjustment which has been authorised by Scottish Government.
- The annual audit of COPFS received a clean audit report.
- P5 August forecast has been completed. Current initial overspend forecast stands at £0.8 m, down from £3.1 m forecast in July 2022. After budget transfers due at SBR, this brings the overspend down to almost a balanced position.
- Liaison work continues in relation to the Resource Spending Review (RSR)
- Financial modelling for budget round 2023 2024 is being prepared in advance of budget discussions with Scottish Government.

### 5. Revision of Witness Expense Rates

MA presented Paper RC 25 (2022).

After general discussion, the paper was approved with the proviso that the new rates will apply to COPFS witness expenses claims for attending court on dates from **1 November 2022**.
